Dear Ms. Yu:

Oilfield Water Logistics (OWL) and KJE respectfully requests deferral of the OCD requirements to complete further investigations and remediation for Case No. 1RP 4497 adjacent to and below the subject pipeline. The GPS coordinates of the extent of this area are 32° 04' 45.25" N, 103° 13' 54.73" W; 32° 04' 44.49" N, 103° 13' 54.02" W; 32° 04' 39.38" N, 103° 14' 01.67" W, and 32° 04' 40.17" N, 103° 14' 02.41" W which are illustrated on the attached Sheet A1. OWL and KJE request that the remediation be delayed until the pipeline is removed or relocated in the future to prevent possible damage to, or reduction of the pipeline structural integrity which could cause an additional spill. When the pipeline is removed or relocated in the future, OWL will contact NMOCD to discuss required investigations, or remediation which may or may not be required at that time.
