Please be advised that

- 1. This release occurred in District 2, but since the associated API well is in District 1, I will be the correspondent.
- 2. The impacted area is mostly on State surface (2M-26S-31E). However, there is a portion of the release that impacted Federal surface: South of Pipeline Road (11D-26S-31E) and any portion that crosses West of the lease road into Section 3P.
- 3. Like approvals must be granted by all corresponding agencies: Mark Naranjo (NMSLO) and Shelly Tucker (BLM).

NMOCD approves of the proposed additional delineation for 1RP-4854 with the clarification that each sample location (S-4, S-5, and S-15) must have two depths demonstrating permissible levels of chlorides in laboratory analyses: depth obtained and depth maintained at least 2 ft. further in depth.

For proposed remedial activities:

- 1. At the areas represented by S-2 and S-8, bottom samples and edge/sidewall confirmation samples are required. Sidewall samples should be no greater than 50 ft. apart.
- 2. On an appropriately scaled map, 1) areas with differing depths of excavation must be clearly outlined and annotated; and 2) delineation and confirmation sample locations demarcated with GPS coordinates.
