- Please be advised that the release is located in core Lesser Prairie Chicken habitat and BLM timing stipulations apply.
- NMOCD database indicates release location is on Federal mineral ownership. BLM can verify.
- While depth to groundwater is estimated to be still > 100 ft. bgs, there is a USGS well slightly closer, 1.3 miles North, of the release location.

NMOCD approves of the proposed delineation for 1RP-3678 with one modification. Please note that the permissible chloride levels are incorrect. Chloride concentration for delineation and remediation is 600 mg/kg. Also, recent aerial imagery depicts the tank battery as removed, which would facilitate deeper vertical delineation, if necessary.
