Notes:

- Please be advised that there is a NMOSE-identified waterway within 1000 ft. of the release location. NMOCD has an Oil and Gas Map on the main page. Please utilize this resource as a reference for hydrology assessment.
- There is a USGS water well, approximately 1000 m North of the release location, with data from 1991, indicating depth to groundwater to be around 18 ft. bgs.

NMOCD will agree that delineation is completed for 1RP-4909 with stipulations to the proposed remediation plan, taking the above information into consideration and revision of RRALs.

- 1. For the area represented by T-1, excavate to 1 ft. bgs and for T-2, excavate to 4 ft. bgs.
- 2. Confirmation bottom and sidewall samples are required for each of the different depths of excavation. Laboratory analyses of TPH extended and chlorides are required.
- 3. Include in the remediation report, an appropriately scaled map with 1) the confirmation samples locations and release point marked with GPS coordinates; and 2) outline and annotate the 2 areas with different depths of excavation.
- 4. Photo documentation of delineation and remediation activities.
