Mr. Millard:

Thank you for the prompt update regarding 1RP-4809. Please be advised that to complement information already submitted for the meeting on April 9, 2018, NMOCD requests that

1. subsequent sample locations to be as close as feasible to the preliminary delineation sample locations for data continuity.
2. GPS coordinates for sample locations to be tabulated along with field and laboratory analyses. This is especially important if a deferral for not remediating sections of the release area will still be requested.
3. Laboratory analytical reports with chain of custody for October 5, 2017 and January 30, 2018 sample dates be included with the second stage of delineation.

Nice to see you again and meet the other involved parties this morning at 10:30 am MST. Pardon, I did not get a card from Mr. Price, so please share the message with him.

I conferred with Jim Griswold- NMOCD Environmental Bureau Chief- and the assessment is that release characterization must be completed before addressal of remedial activities. The data presented are acceptable preliminarily, but horizontal and vertical delineation will still be required for 1RP-4809.

Please be advised that a deferral is not applicable to delineation, only granted for specific circumstances, in which remediation is not feasible or practicable due to infrastructure or accessibility.
