Describe Cause of Problem and Remedial Action Taken.*

Release of 1 bbl of oil and 17 bbls of produced water due to a 3" poly flowline due to freezing temperatures. ~ 10 bbls of produced water were recovered. The release occurred on the pad and measured approximately 78' x 39' and in a pasture area approximately 39' x 69'. Subsurface assessment in the release area revealed TPH, BTEX, and chloride concentrations below target levels.

Describe Area Affected and Cleanup Action Taken.*

Since concentrations were below the target levels, a closure report was submitted to the NMOCD and approved.
