NMOCD shares BLM's consideration for completion of vertical delineation of BTEX for the area represented by AH-5. In addition, NMOCD requests that vertical delineation of TPH extended for AH-4 and AH-5 be completed as well. Since the preliminary samples were taken by an auger, is another method feasible in this location? Please provide photo documentation of impacted area for evaluation.

Regarding the proposed remedial activity, what is the likelihood of Microblaze working successfully subsurface up to 2.5 ft. bgs? Is tillage proposed?
