Good morning Mr. Arguijo:

Notes:

- Release point needs to be marked on scaled figures.
- SP-12 is designated incorrectly on Figure 2. No additional delineation is needed for SP-12.

NMOCD approves of the proposed delineation plan for 1RP-4968 with a few caveats. In the interest of attempting to maintain the hydrologic functions of the playa lake, a waterbody of NM:

1. NMOCD requests the use of a mechanical auger (e.g., geoprobe) to delineate the edges of the playa, SP-5, SP-7, and SP-8 rather than a backhoe to dig trenches.
2. Please be advised that a caliche layer is not an acceptable rationale for incompleteness of vertical delineation; therefore, consider the use of a soil borer to complete release characterization.
3. NMOCD determines that investigation of the dimensions and location of the emplaced liner is not necessary.
4. Since none of the presented data indicated BTEX or TPH contamination, further vertical delineation at specified locations do not need hydrocarbon analyses. For horizontal delineation sample locations, NMOCD agrees with the proposed plan of selected representative samples for BTEX and TPH analyses.
