Thank you for your prompt response. Yes, an extension is granted for 1RP-4765.

If available, please 1) submit all data from field tests and laboratory analyses from the previous contractor; 2) photo documentation of the original release area for verification of the excavated area; and 3) GPS coordinates of the dimensions of the impacted area as well as delineation/remediation sample locations.

Please note that release area is in LPC habitat. Current BLM timing stipulations apply.
