Mr. Brunson:

NMOCD approves of the delineation for 1RP-4658 and proposes a modified remediation plan. At 1 ft. bgs, chloride levels are still above permissible values at SP1, SP2, and SP3.

1. NMOCD proposes excavation to 2 ft. bgs for the areas represented by SP1 – SP3.

- Sidewall confirmatory soil samples for chloride levels are required.
2. No excavation is necessary for the area represented by SP 4 and SP5.
 3. Demarcate depth of excavation for SP1, SP2, and SP3 areas and location of sidewall samples on an appropriately scaled map.
