Notes:

- District 1 has an additional Environmental Specialist. Please include Christina Hernandez in all future release notifications and report submittals.
- If the anticipated depth of excavation cannot be obtained, please provide NMOCD at least 48 hours of advance notice for an opportunity to site visit.

NMOCD approves of the delineation completed and proposed remediation for 1RP-4732 & 1RP-4738 with these stipulations:

- Sidewall confirmation samples are required for both the proposed excavations in the pasture and in the tank battery areas.
- Bottom confirmation samples are required for each of the differing depths of excavation as highlighted in the data tables. IF differing depth of excavations, annotate scaled map accordingly.
- GPS coordinates for the dimensions of all areas to be lined with a minimal 20 mil liner at approximately 4 ft. bgs. For example, demarcate the lined areas represented by BH-7 and BH-9.
- Photo documentation of delineation and remediation activities, including proper emplacement of a liner.
