NMOCD also approves of the proposed delineation plan for 1RP-5069. Please note that USGS has more recent depth to groundwater data in the vicinity of the release location. Estimated depth to groundwater is < 100 ft. bgs (data from 2015 indicates 63 ft. bgs) within a 1000m radius, which alters the permissible delineation and remediation levels.

Also, please remember that each proposed differing depth of excavation must have its own set of confirmation bottom and sidewall samples.
