Per your email request with specific detailed information, Chevron MCBU is requesting a six month extension (July – December) from NMOCD for our Salado Draw 1RF-11 & 1RC-11 Recycling Containments (Frac Ponds). December 2017 was the last month this recycled water was utilized. We will be exceeding the six months of not utilizing >20% of the total fluid capacity as of June 30, 2018, due to our Salado Draw Pad 8 drilling rig encountering issues and has pushed our frac start date to July.
