Thank you for the update. I can sympathize with the confusion regarding release notification. Please submit a signed C-141 to all relevant agencies, NMSLO and NMOCD in this instance. If it is easier, you may use this email thread. This is the easiest and fastest way to ensure proper notification is given to all relevant parties that I am aware of. I will include all those mentioned in your email in all correspondence to ensure everyone is informed, but until 9/30/2018 I will consider you the lead contact for this issue unless I hear differently from you. Review of the NMOCD website indicate there are now going to be 7 open remediation permits at this site (1RP-3512, 1RP-3621, 1RP-4305, 1RP-4855, 1RP-4960, and the most recent release on 6/20). Please inform if you have any

updates on any of these. Reviewing the online documents indicates that some have had delineations, most have not. Perhaps there are documents previously submitted by yourself that haven't made it to the online database. At any rate, delineation is essentially voided after another releases occurs in the same area prior to remediation. All of these should be addressed and resolved at the same time as they most likely overlap to some degree. NMOCD and NMSLO will certainly work with Mr. Merrill or anyone for approval of work plans. Please contact me if you have any other questions or are unclear about any other documentation processes.

Mr. Mann,

E-tech environmental has been contracted to handle all remediation of Permian Water Solutions spills. Mr. Kim Merrill will be heading up their efforts (e-mail in CC line). E-tech replaces Trinity Environmental, who did not execute cleanup in an acceptable timeframe. That timeframe, it now appears, may not have been entirely under their control.

Denise Jones handles Cambrian Managements regulatory filings. Our contract to manage field operations for Permian Water Solutions will expire Sept 30, 2018. At that time Mr. James Corbitt and Mr. Dale Glossen will be handling these projects as well as Mr. Rob Hendricks. C-141s for this site include several for the same area of ground, some of which is over liner and some of it is not over liner. Plans to remediate all of the areas of contamination are in place but we cannot move dirt until delineation plans and work plans have been approved. That has been reset. I am encouraging Mr. Merrill to review with Ms. Yu any approved plans regarding the Kaiser facility.

As for your confusion about our process, imagine how we must feel contacting 2 different state offices regarding the same incident and filing the same document type online in some instances and by mail in others. With e-mail these can be autoforwarded to you internally.

Thank you for your patience as we attempt to navigate the process.

When creating original documents, we save to the server unsigned copies, we signed in alternative color ink to demonstrate original signature and you, no doubt have received via USPS the signed original and we usually send copy/working copy with the original. If that was not the case I will review standard procedures in house. Denise does not usually make errors. The copy I sent you was direct from the server and is not signed. C-141 does not show to be an online available form according to the website. A copy of the original signed c141 was filed in the paper file as well, and I find it unlikely she would have gone to the trouble of making a copy for the paper file without the form being submitted. I am disappointed that this has risen as an issue when she made every attempt to comply.
