Thank you for your patience. NMOCD approves of the proposed additional delineation for 1RP-4836 with several modifications:

- 1. Proposed sample locations CD-8, CD-9, BUC-20, BUC-21, D-22, D-23, and D-24 are not necessary. More importantly, complete vertical and horizontal delineation for the area presented by CD-2 and BUC-1. Establish a sample location to the East and midway of CD-2 and BUC-1.
- 2. BUC-22, BUC-23, D-27, and D-28 sample locations are also not necessary. Complete vertical delineation for the area represented by CD-1, though the use of a mechanical auger, such as a geoprobe, or backhoe if possible.
- 3. As CD-1 and CD-2 had elevated chloride levels at 30", laboratory data are expected to be from surface, 1 ft, and then 2 ft-interval afterwards, until permissible levels are obtained. Provide any field data for the in-between depths.
- 4. To address the eastern portion of the well pad, represented by delineation sample locations D-1 to D-8, the recommendation is to establish 2 sample locations, West of general vicinity of D1/3/4/5 area and East of D-2 (other side of berm). Laboratory analyses of surface, 1 ft. and 2 ft. intervals thereafter. Provide any field data for the in-between depths.
- 5. Use field chloride titration tests to guide the lateral extent of chloride impacted soil East of CD-2 & BUC-1 and West of BUC-22 and BUC-23.
