Mr. Fulks:

Please note that one of the sample location was off location; therefore, the release was not entirely within the berms as written.

In the interest of resolution, NMOCD will close 1RP-4725. However, please be advised that the statements in the email dated April 12, 2018 are conditions of approval. Demarcation of confirmation sample locations on a scaled map and photo documentation were required for verification. Please ensure that field instruments and equipment have the capacity to satisfy these requirements.

The available information indicates **OPERATOR** has met the requirements of 19.15.29 NMAC and no further corrective action is required. NMOCD considers **1RP-4725** closed. However, this determination by the Oil Conservation Division does not relieve Operator of responsibility should future information indicate a threat to ground water, surface water, human health, or the environment. Furthermore, it does not relieve Operator of responsibility for compliance with any federal, state, or local laws and/or regulations.
