Mr. Fulks:

In the interest of resolving 1RP-4734, NMOCD will close this 1RP. However, for future releases, per revised NMAC 19.15.29, photo documentation of the remediated and restored release area must be provided. Moreover, as stated in the email dated August 31, 2017, confirmation sample locations must be marked on a scaled map. Please note that there is a discrepancy between the depth of confirmation bottom samples stated in the laboratory chain of custody and the tabulated data.

The available information indicates **OPERATOR** has met the requirements of 19.15.29 NMAC and no further corrective action is required. NMOCD considers **1RP-4734** closed. However, this determination by the Oil Conservation Division does not relieve Operator of responsibility should future information indicate a threat to ground water, surface water, human health, or the environment. Furthermore, it does not relieve Operator of responsibility for compliance with any federal, state, or local laws and/or regulations.
