In regards to 1RP-4854, why was sample location S-15 established then, if not associated with the current release? If Swiftwater is not the Responsible Party, who holds the lease for this location or owns the flowlines adjacent to Pipeline Road? The impacted soil represented by S-15 still will require delineation and remediation activities.

Proposed remediation will not be addressed until additional delineation is completed for 1RP-4854.

1RP-4871 will be addressed in a separate email.

My apologies for not including the BLM on the initial email. I realized the omission and sent a separate email following the submittal to the NMOCD. I will be sure to include them on all communications and report submittals moving forward.

Delineation activities for 1RP-4854 include the initial delineation performed by Talon (posted on NMOCD website [here](#)) and the follow up delineation led by RXSoil described in the report, completed 6/6/18. This follow up was to address the stipulations given via email ([here](#)) for locations S-4 and S-5. Delineation was not continued on sample location S-15, as it was determined by Swiftwater that the area surrounding borehole location S-15 was not part of this release and therefore will not be addressed in this remediation plan.
