Mr. Thomas:

Thank you for your patience. NMOCD will formulate a list of criteria to evaluate alternative remediation proposals. In the meanwhile, this process would be facilitated if the Responsible Operator requests that the environmental consultancy submit to NMOCD, scientific documentation demonstrating that the proposed product/process will be 1) protective of the environment, 2) effective in addressing the contaminants in oilfield releases, and 3) supportive of revegetation potential/efforts.

NMOCD approves of the vertical delineation completed for 1RP-5059. Please be advised that each proposed different depths of excavation will need a respective set of confirmation sidewall and bottom samples. For example, one of sidewalls must be at the border between the proposed 18-inch and 4 ft. excavation areas. Optimally, confirmation sidewall samples no greater than 75 ft. apart, which would also serve to complete horizontal delineation/release characterization.

If applicable, approval from BLM required. BLM may have additional concerns and stipulations.
