Good morning Mr. Green:

NMOCD will need photo documentation for verification of release area for 1RP-4983. Also, the East sample location will need to be addressed. When equipment is mobilized to conduct remedial activities, please complete delineation for the area represented by East-1 sample point.

NMOCD will agree that vertical delineation is completed for defined area under 1RP-4983.  
For the proposed remediation plan:

- Confirmation sidewall samples must be no greater than 50 ft. apart. There is no apparent infrastructure in place to prevent sidewall samples adjacent to the lease road.
- Mark confirmation sample locations, in relation to delineation sample locations and release point, on a scaled map with GPS coordinates.
- Provide dated photo documentation of the remedial activities, including proper emplacement of a minimal 20 mil liner.

Like approval from BLM required.
