To facilitate processing of these gaseous emissions, please complete C-141 form submittals with these recommendations:

- There are shapefiles or .kmz files that are readily accessible and free for ESRI ArcGIS or Google Earth, respectively.
- Check with internal Right-of-Way operations or personnel regarding surface and mineral ownerships.
- If the same C-141 template is used for all reporting of gaseous emissions, the OGRID only need to be written once and there will be no confusion regarding the appropriate Responsible Party for the release.

Please be advised that

- 1. Per 19.15.29.13 NMAC, regulations of corresponding agencies supersede NMOCD's.
- 2. Dated and georeferenced photos for the release point of these gaseous emissions are needed for closure. There are many apps capable of adding this information to pictures taken on a phone, which would facilitate quick resolution of these C-141s. Also, one of these photos need to be of the corroded pipeline to verify that there was no surface impact.
- 3. The release location for this gaseous emission is adjacent to Trunk MC-16 (1RP-4524). What is the relationship, if any, between these two lines?
