- Please remember to check surface and mineral ownerships upon submittal of a C-141 form to ensure that all corresponding agencies are informed concurrently. For this release, NMSLO is both the surface and minerals owner. NMSLO can verify.
- In order for the appropriate Responsible Party to be attributed, please provide an OGRID code. NMOCD databases indicate more than 1 OGRID available for Phillips 66. No need to resubmit, an email response suffices.

Please be advised that

1. The initial portion of the C-141 form does not include the calculations to determine the release volume. Visual estimation is not sufficient nor adequate. Please submit measurements in volume estimation; such as dimensions (L X W X depth of impact), soil parameters (porosity, texture, bulk density, soil moisture), meter readings, waste manifests, etc.
2. Dated, geo-referenced photo documentation for verification that the initial response activities have been employed to contain the release is requested.
3. Per 19.15.29.13 NMAC, regulations of corresponding agencies supersede NMOCD's.

Good Morning Olivia

On 9/28/2018, due to unknown causes crude oil was released from a gathering pipeline onto the ground. The location of the release is: Latitude 32° 47' 59" N Longitude 103° 27' 45" W. P66 emergency response team traveled immediately to the release location. It was initially estimated to be 22 bbls.

P66 emergency response and field personnel completed the following field actions:

- 1-The source of the release has been stopped.
- 2-The impacted area has been secured to protect human health and the environment.
- 3-Released materials have been contained via the use of berms or dikes, absorbent pads, or other containment devices.
- 4-All free liquids and recoverable materials have been removed and managed appropriately

On 9/29/2018 additional field information were available and the estimated release is 220 bbls.
