Thank you for the patience. Although the release point that was written on the initial C-141 was on State surface; according to NMOCD database, most of the release area on the lease road (areas represented by T-4 to T-10 trenches) shown in the closure report for 1RP-4744 is on Federal surface. BLM and NMSLO can verify.

Please be advised that the confirmation samples taken on August 14 and 17, 2017 are not within the acceptable soil temperature range. Please note that under revised 19.15.29 NMAC, NMOCD can elect to deny closure.

While vertical delineation was not shown to have been completed for Trench 3 area; as depth to groundwater is > 100 ft. bgs, NMOCD will grant closure to 1RP-4744. NMSLO and BLM approval required. If applicable, corresponding agencies' may have additional concerns and stipulations.

The available information indicates **OPERATOR** has met the requirements of 19.15.29 NMAC and no further corrective action is required. NMOCD considers **1RP-4744** closed. However, this determination by the Oil Conservation Division does not relieve Operator of responsibility should future information indicate a threat to ground water, surface water, human health, or the environment. Furthermore, it does not relieve Operator of responsibility for compliance with any federal, state, or local laws and/or regulations.
