Good morning Brad,

Both locations have approved registered C-147 applications.

- Hayhurst NM C-147 (2RF-107) is the one for Section 9 & 10 RWCS and Section 2 Recycle Facility.
- Salado Draw C-147 (1RF-11) is the one for Section 23 RCWS and Section 13 Recycle Facility.

I believe we agreed that the fixed recycle units could be added to these existing C-147's. If this is not the case, please advise if a C-147 short form would need to be submitted for this fixed recycle unit that will be installed at the Section 2 for Hayhurst and then next year be moved over to the Salado Draw section 13 Recycle Facility.

Reason for the change: Since we experienced issues with drilling pad 8 at Salado Draw, the unit is not needed until 1st qtr. 2019, so we will be utilizing it at the Hayhurst Section 2 Recycle Facility.

Note: After we move it from Hayhurst Section 2 Recycle Facility, my understanding is that we will not be bring another unit #3 to replace. We will only have units #1 & #2, which I have submitted that information via email on 6/28/2018.

Please give me a call if you need more details of what we are trying to accomplish with this 3rd recycle unit at Hayhurst NM Section 2 Recycled Facility.
