COG currently does not a have a policy regarding delineation and considers each site on a case by case basis. COG is currently evaluating the newest delineation requests by the NMOCD. This spill was addressed immediately after the release by operations and when sampling was conducted by our contractor, no impact was found. In this case, no constituents of concern were found over the permissible levels for Benzene, BTEX, TPH or chloride. There isn't any scientific evidence that should require delineation to 10 feet. Also, please clarify your last question regarding the 4 foot sample.
