A pleasure to meet you in person yesterday. After our discussion about delineation in locations with a shallow water table (≤ 50 ft), NMOCD still requests additional vertical delineation for 1RP-4478 & 4479 with a few adjustments.

As per our discussion regarding this location as a new well site, NMOCD request laboratory analyses of chloride levels for bottom confirmation samples at AH 2, 5, 10, 11, and 15 at 8 ft. bgs, which was indicated as the maximum extent of a backhole. Please provide field and/or laboratory data of the intermediate depths with depth intervals of 5 ft. maximum between samples. Please confirm.

After reviewing the data in question, the chloride concentrations detected in the shallow soils (0-1') were not significant and the deeper samples showed consecutive concentrations that are not an environmental concern. In addition, this site location is a new drill.

I would like some clarification and justification on collecting the deeper samples. If needed, I would like to meet with you and Tomas at your office to discuss further. I would like to discuss sampling
