## Mr. Brunson:

Please note that NMOCD does not have records of confirmatory samples or a final C-141 for 1RP-3625. Please inform if this workplan will also include the release area for 1RP-3625.

NMOCD approves of the proposed additional delineation and remediation plan for 1RP-3973, 1RP-4093, 1RP-4118, 1RP-4267, 1RP-4339, and 1RP-4689 with these stipulations:

- For the release on January 18, 2016 (1RP-4118): bottom confirmation sample needed for the proposed 3.5 ft. excavation for the area represented by SP2. Situate additional bottom confirmation samples for the area represented by SP3 and SP5 closer to the original sample location from March 31, 2016 sample date to ensure that the elevated chlorides at 1 ft. bgs were removed completely.
- A confirmation sidewall sample is required at the western side of the release on April 22, 2016 (1RP-4267), overlapping the release from January 18, 2016 (1RP-4118).
- If the proposed depths of excavation are not within permissible levels, please proceed to the next foot. Due to the multiple releases at this location, laboratory analyses for TPH extended (GRO, DRO, MRO) and chlorides are required for all confirmation samples. BTEX samples are required for confirmation samples in the tank battery area and the additional delineation area for 1RP-4267, which overlapped the release for 1RP-4118.
- Tabulate GPS coordinates for all confirmation and delineation sample locations as well as the dimensions of the lined areas.
- Dated, optimally geo-referenced, photo documentation of remedial activities, including proper emplacement of a minimal 20 mil liner is required.
