Please address these concerns regarding the delineation workplan for 1RP-4509.

- 1) According to the unscaled drawing, the reported 10 bbls release covered a larger area than expected given the analytical results. Please confirm dimensions of contaminated area on scaled digital map.
- 2) There appears to be pooling at SP 1 and SP2. Chloride levels increase back up at 2ft. bgs. Excavate to 2 ft. bgs at SP1 and SP2 and obtain bottom confirmation samples.
- 3) Obtain bottom confirmation samples after 6" removal of contaminated soil at SP3 for BTEX, TPH, and chlorides.
