According to SESI field technician, the spill was very large, so the spill was divided into 2 sections, and labeled C and D.
2. [Do the depths indicated in the sample ID reflect the depth of the excavation around each of the sample points?](#)
According the SESI field technician, yes, the depths indicated reflect the depth of the excavation around each of the sample points.
3. [Tabulate the depth of excavation for each of the sample locations.](#)
According to the SESI field technician, A-1ft; C-5ft; D-3ft
4. [Seems that confirmation sample was not taken at SP6. Was there a reason? Does the absence of confirmation bottom sample for SP6 indicate that no additional excavation was needed or conducted at this spot?](#)
According to the SESI field technician, SP-6 was a small 2 x 6 area on the lease road.

Olivia Yu has some questions on the closure report done for JNB Transport, in regards to an oil clean up on a GMT Exploration location. SESI had led the efforts, and followed through with the closure report. I believe they would be best suited to answer some of these questions listed below.

I have several questions about the confirmatory lab analytical data provided in the closure report for 1RP-3405. Please communicate with SESI if you do not have the requested information below.

1. Please clarify the sample ID. What does C and D represent?
2. Do the depths indicated in the sample ID reflect the depth of the excavation around each of the sample points?
3. Please demarcate on the map the extent of the release and where North and South wall samples were taken.
4. Tabulate the depth of excavation for each of the sample locations.
5. Seems that confirmation sample was not taken at SP6. Was there a reason? Does the absence of confirmation bottom sample for SP6 indicate that no additional excavation was needed or conducted at this spot?

I will be happy to help in any way I can. Please keep me in the loop regardless, so that I know when Olivia is satisfied with the information, and the NMOCD can close this report. I have attached the closure report as well for reference.
