Ran temperature survey indicating TOC @960'. PU 1" pipe & tag @ 967'. Cmt 1st plug w/350 sks Class C w/2% CaCl2. Mixed @ 14.83/g w/1.34 yd. Circ 20 sks of cmt to pit. Tested BOPE to 3000# & Annular to 1500#. At 7:45 PM 01/01/13, tested csg to 1500# for 30 mins, held OK. Drilled out with 8 3/4" bit.
