4/15/13 - Pumped down bradenhead between 9-5/8 inch casing and 5-1/2 inch casing at 4.5 BPM at 700 psi at start of pump test. Pumped 300 bbls 9Lb brine at 4.5 BPM at 500 psi. Shut bradenhead in at 500 psi, holding pressure steady.

4/17/13 - Pressured up annulus to 1500 psi. Tie into bradenhead. Pumped 900 sx 35/65 Poz C cement mixed down bradenhead between 9-5/8 inch and 5-1/2 inch casing and open hole. NOTE: Jack Johnson with BLM-Hobbs witnessed cement job.

4/24/13 - NU BOP.

4/25/13 - Ran CCL/GR log from 7000 ft up to surface with 1000 psi. Pumped 60 bbls down tubing. ND BOP. Swabbed tubing down to 2000 ft from surface. Packer and 2-7/8" 6.5# L-80 tubing at 10,070 ft.
