6-20-13 MIRU WS & plugging crew. Release pkr & POOH w/tbg. RIH w/WL & set 4 1/2" CIBP @ 3828'. Spotted 60 sks Class "C" (yd @ 1.32 cuft/sk @ 14.8 PPG) on top of CIBP. Found 4 1/2" csg parted @ 620'. Attempted to RIH w/tbg through parted 4 1/2" unsuccessfully. POOH w/parted 4 1/2" csg (611.97'). Made several attempts to get back into 4 1/2" csg w/tbg unsuccessfully. RIH w/ 1 11/16" camera to 630' & did not see 4 1/2" csg. RIH w/tbg & stacked out @ 1145' outside of the 4 1/2" csg & open hole annulus. Pulled end of tbg to 1130'. RIH w/1 9/16" gun & WL. Perforated @ 1136' w/4 shots per ft. Spotted 180 sks Class "C" (yd @ 1.32 cuft/sk @ 14.8 PPG) @ 1130'. RIH w/tbg & tagged cmt @ 960'. Pumped 419 sks Class "C" (yd @ 1.32 cuft/sk @ 14.8 PPG) & circulated cmt to surface. Top off well w/cmt. Cut off csg, dead man anchors & installed dry hole marker. Well P&A'd 7/3/13. Patrick McKelvey w/BLM witnessed work.
