McElvain Energy Inc is requesting approval for a temporarily abandonment status on the Little Lake 16 State #1 well in Lea County, NM. The well was drilled in the fourth quarter of 2014. Although the rig was released on September 25, 2014 it remained stacked out on the well until January 15, 2015. McElvain has postponed completion operations pending further economic evaluation of the well. I have included the cement bond log verifying that the well currently has cement covering all zones of interest.
