1/12/2015 PICKED UP PACKER WITH 1 JOINT. RAN IN HOLE AND TAGGED UP AT 3803'. ATTEMPTED TO SET PACKER. WOULD NOT SET AT THE TAG. PULLED UP TO 3433' AND GOT PACKER TO SET. PUMPED DOWN TUBING AND PRESSURED UP TO 500# AND HELD. WILL NOT TAKE FLUID BELOW PACKER. CALLED JIM AMOS WITH THE BLM AND HE SAID TO PERFORATE AT 3803' AND SQUEEZE. POOH AND RIH WITH WIRELINE TO PERFORATE. COULD ONLY GET DOWN TO 3657 WITH WIRELINE. PERFORATED AT 3657' AS PER FEILD REPRESENTATIVE JACK JOHNSON. RIH WITH PACKER TO SQUEEZE PERFS. PRESSURED UP TO 500# AND HELD. WOULD NOT SQUEEZE. POOH WITH PACKER AND SION.

1/14/2015 RIH AND TAGGED CEMENT AT 2740'. PERFORATED AT 2450'. RIH WITH PACKER. PRESSURED UP TO 500#. WOULD NOT SQUEEZE. SPOTTED 35 SX CEMENT ACROSS PERFORATIONS FROM 2507'. WOC AND TAGGED AT 2005'. LAID DOWN REMAINING TUBING AND SION.

1/15/2015 PERFORATED AT 441'. ESTABLISHED CIRCULATION AND PUMPED CEMENT DOWN 4 1/2" CASING TO PERFS AND UP ANNULUS TO SURFACE. TOOK 140 SX TO GET CEMENT TO SURFACE. CUT OFF WELLHEAD AND FILLED UP BOTH STRINGS WITH 1 SACK CEMENT. INSTALLED MARKER AND CUR OFF ANCHORS.
