Pump 20BFW spacer then cmt w/ 770sx (254bbl) PPC w/ additives 12.9ppg 1.853 yield followed by 350sx (83bbl) PPC w/ additives 14.8ppg 1.326 yield, circ 164sx (64bbl) to surface. Install pack off mandrel, test to 5000#, tested good. 9/30/14 RIH & tag cmt @ 4614', test csg to 2750# for 30 min, test passed. Drill out cmt & drill new formation to 4670'. Perform FIT test to EMW=10.8ppg, 461psi good test.

10/1/14 Drill 7-7/8" hole to 13270'M 8405'V, 10/12/14. RIH & set 5-1/2" 17# P110 DQX csg @ 13270', DVT @ 4846'. Pump 50bbl tuned spacer then cmt w/ 760sx (494bbl) PPC w/ additives @ 9.7ppg 3.654 yield followed by 830sx (245bbl) PPH w/ additives @ 13.2ppg 1.66 yield, with full returns, circ 239sx (156bbl) cmt to surface. Drop cancellation cone, pressure to 4150#. ND BOP, test tubing head to 5000# for 15min, tested good. RD Rel Rig 10/15/14.
