At 1:00 A.M. 10/29/15, tested csg to 1500# for 30 mins, held OK. WOC. Drilled out with 8 3/4" bit.

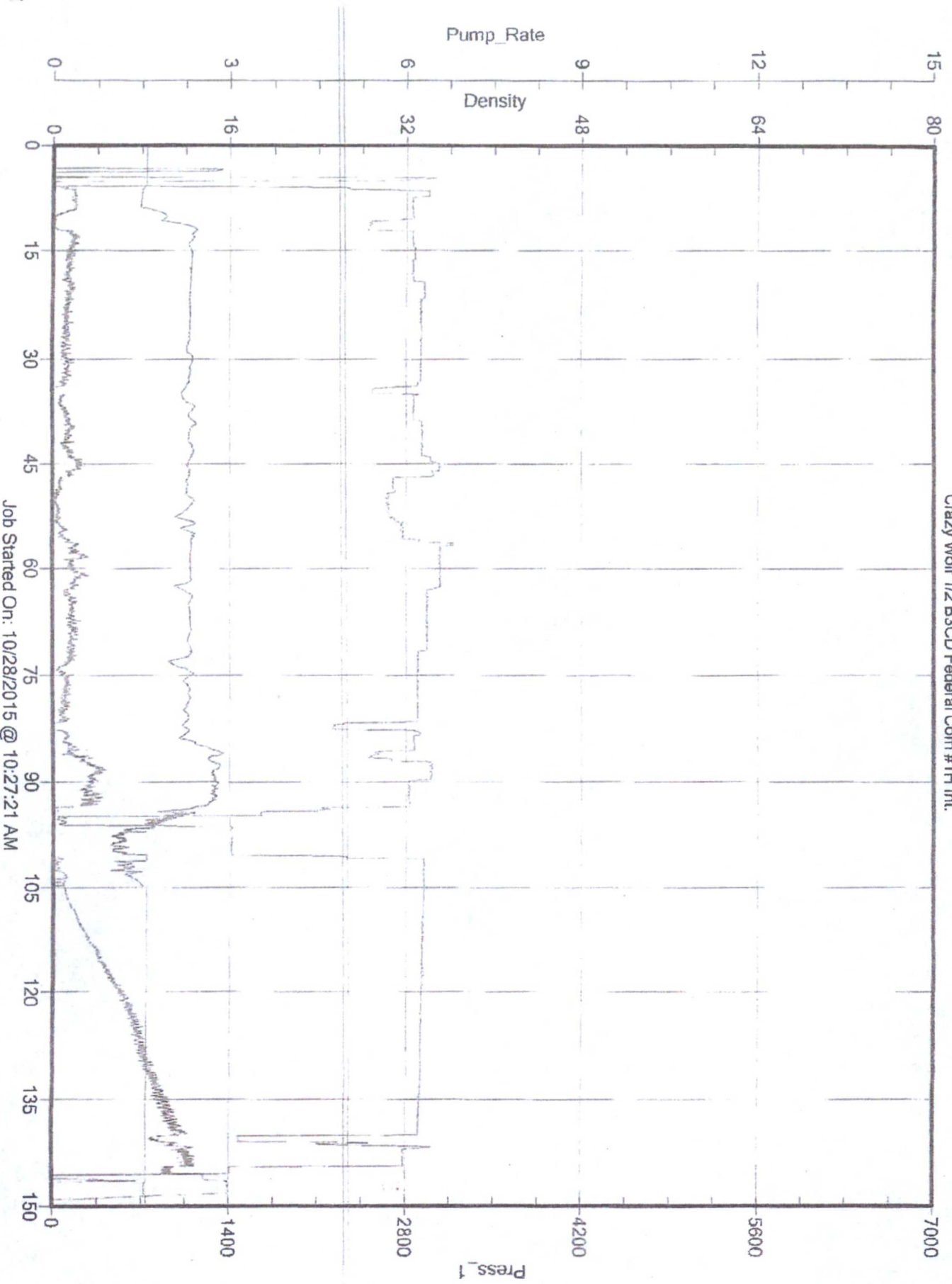
