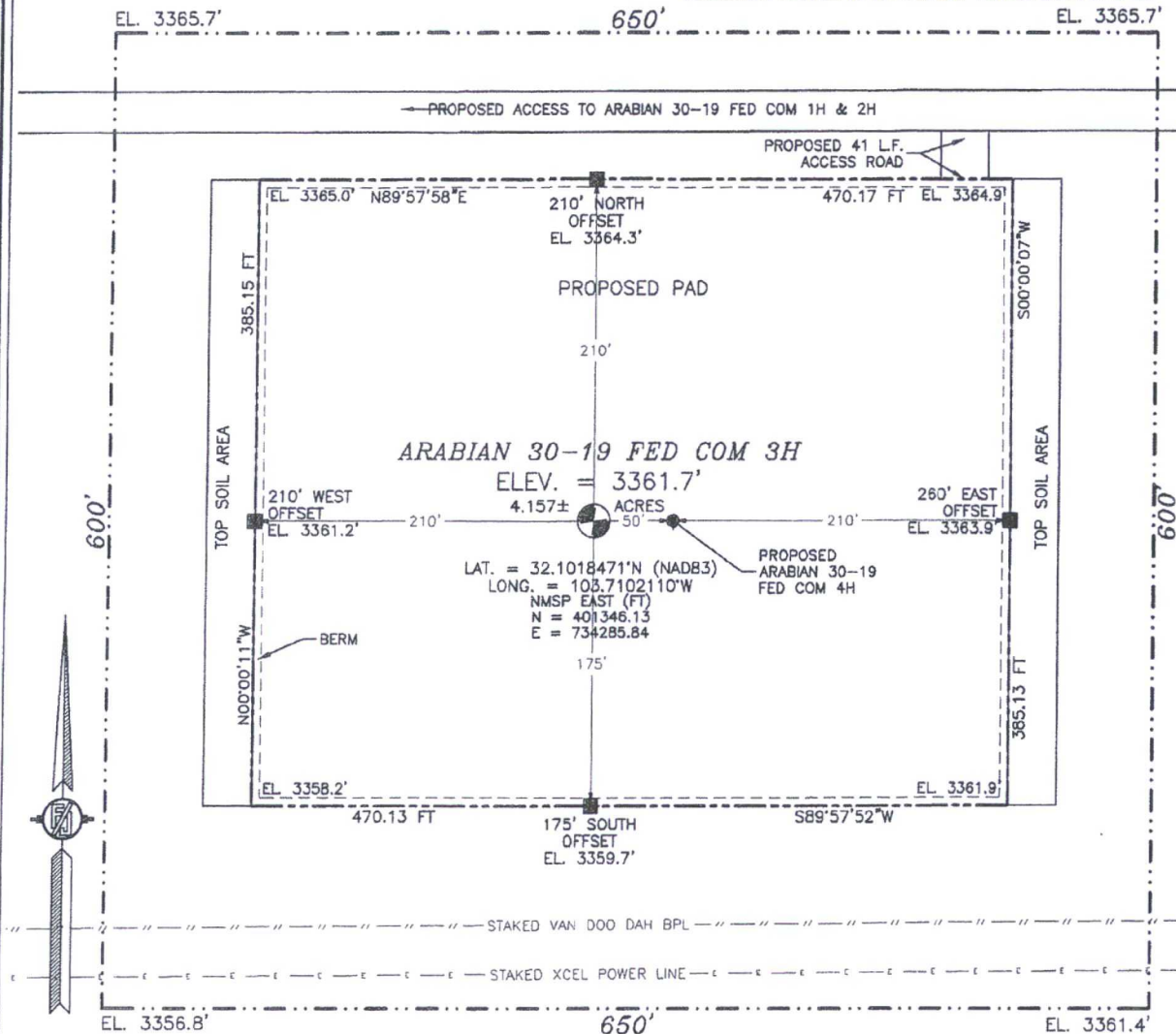

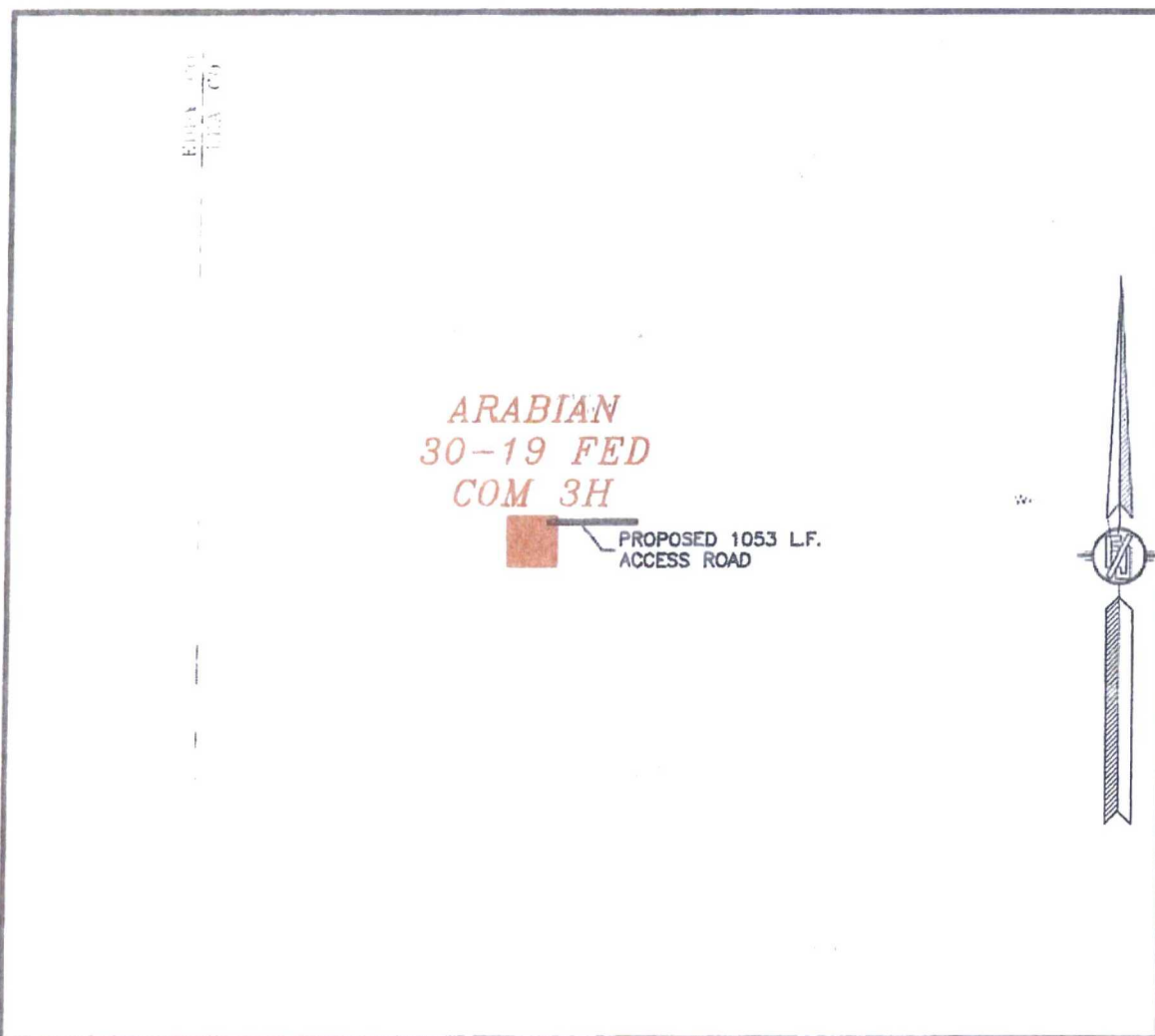

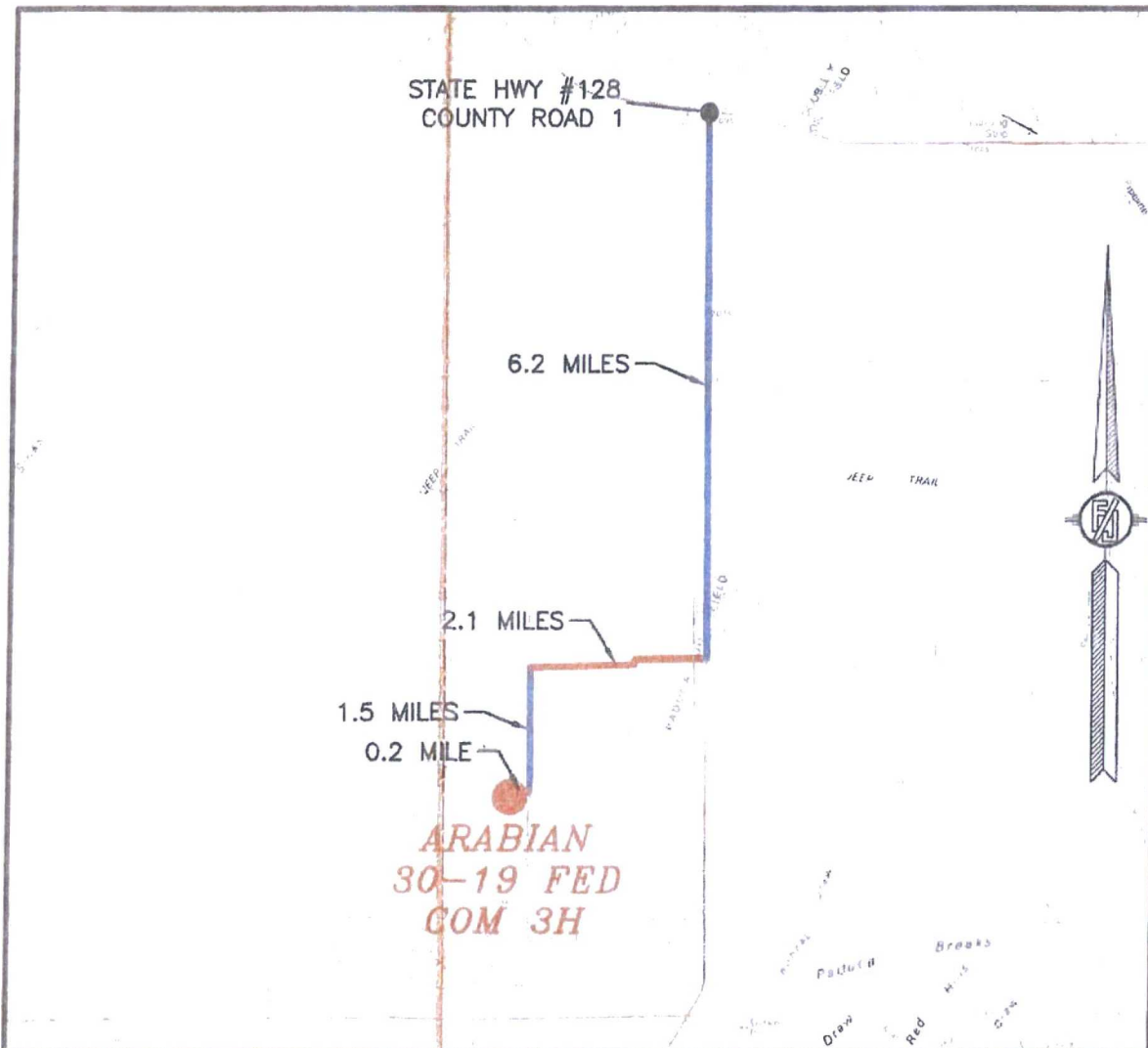

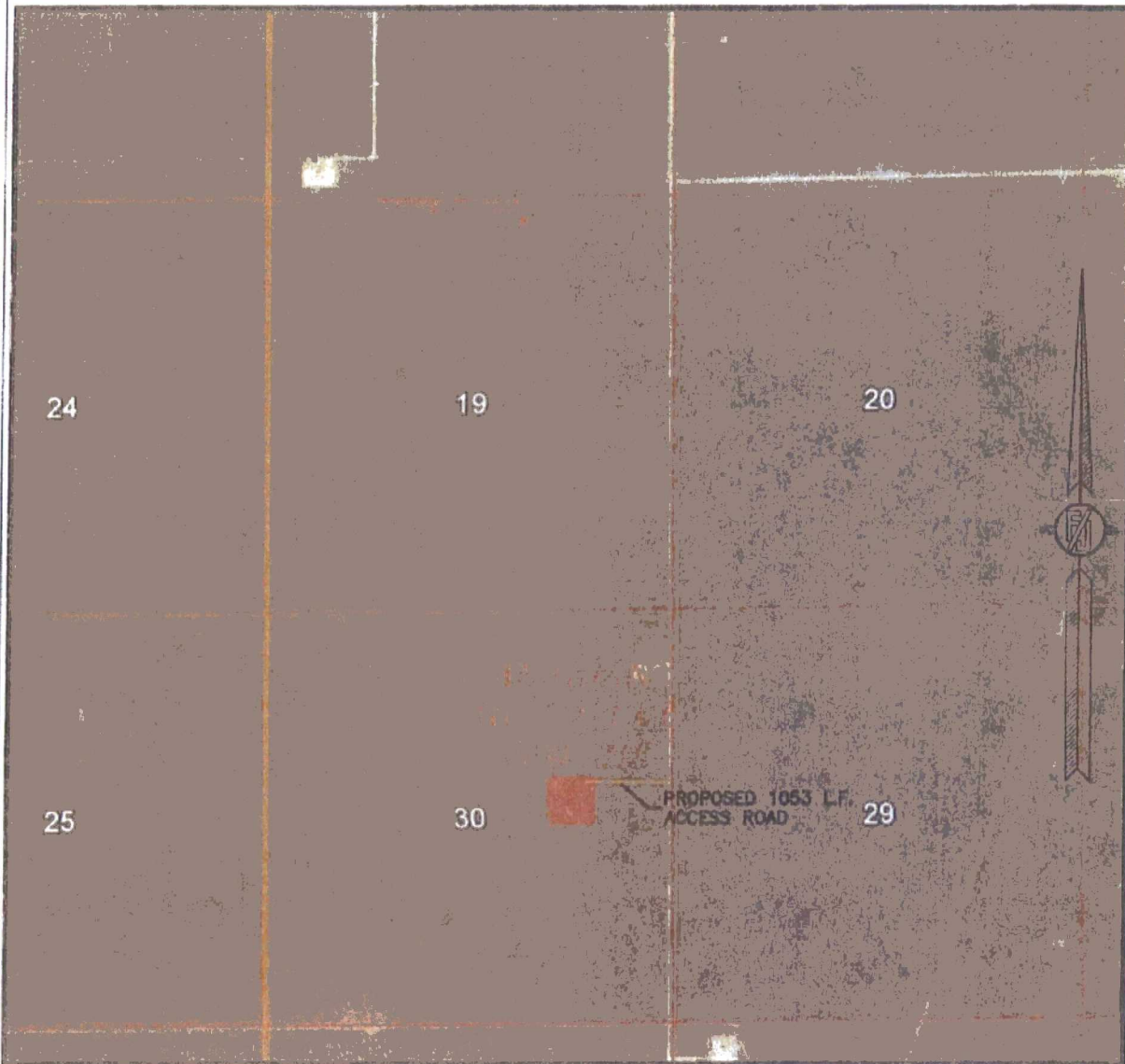

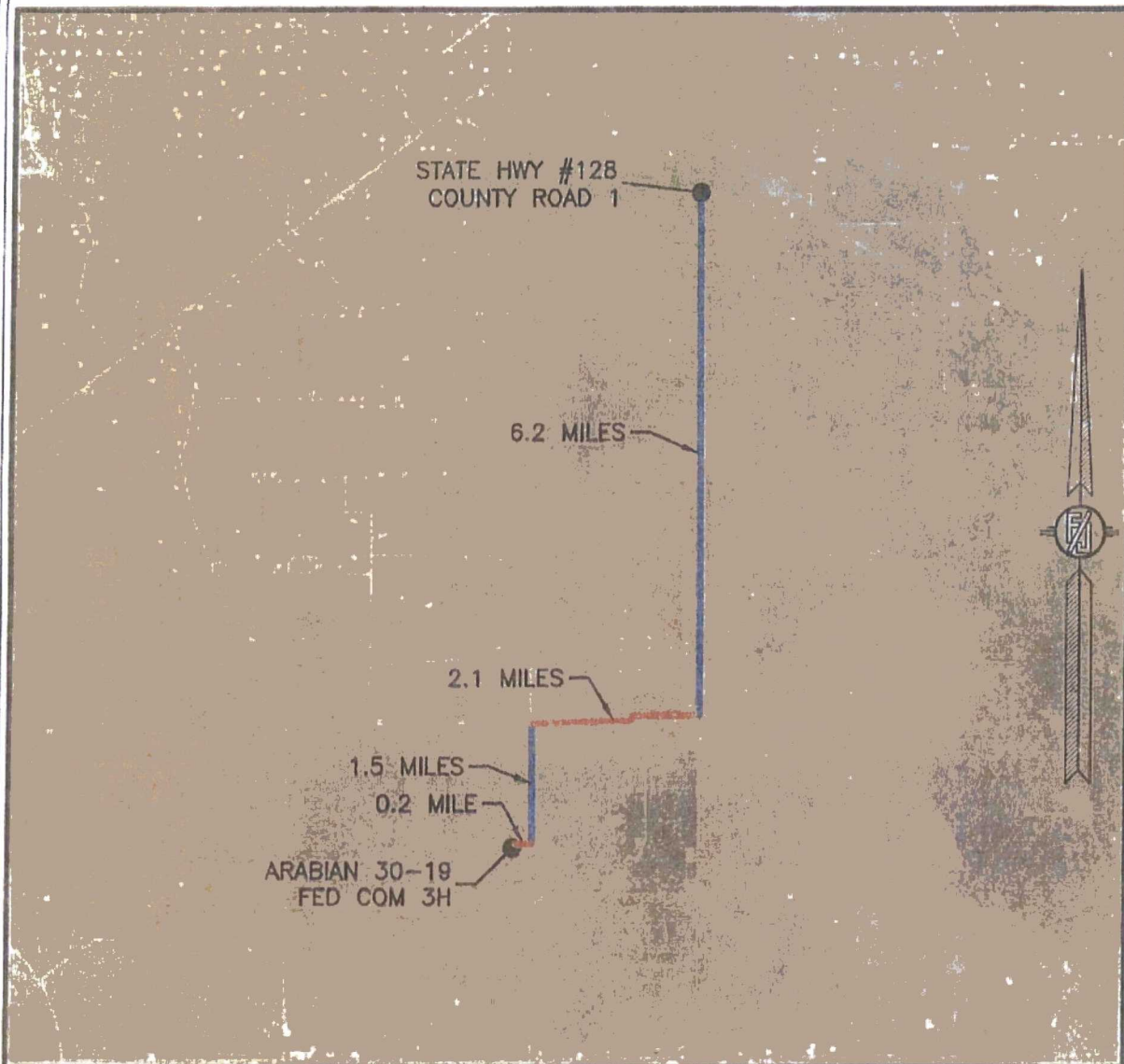

**AERIAL ACCESS ROUTE MAP**



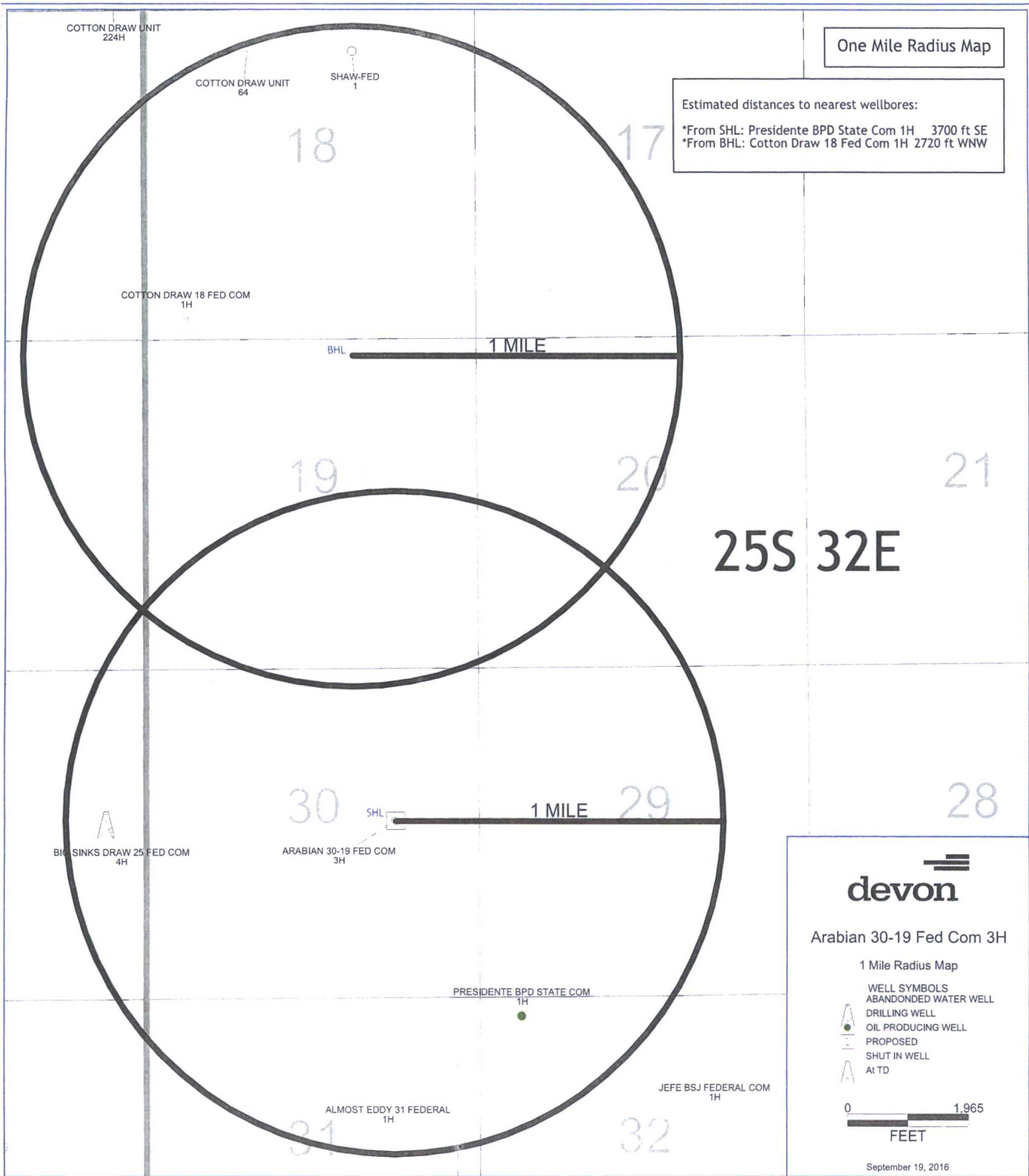

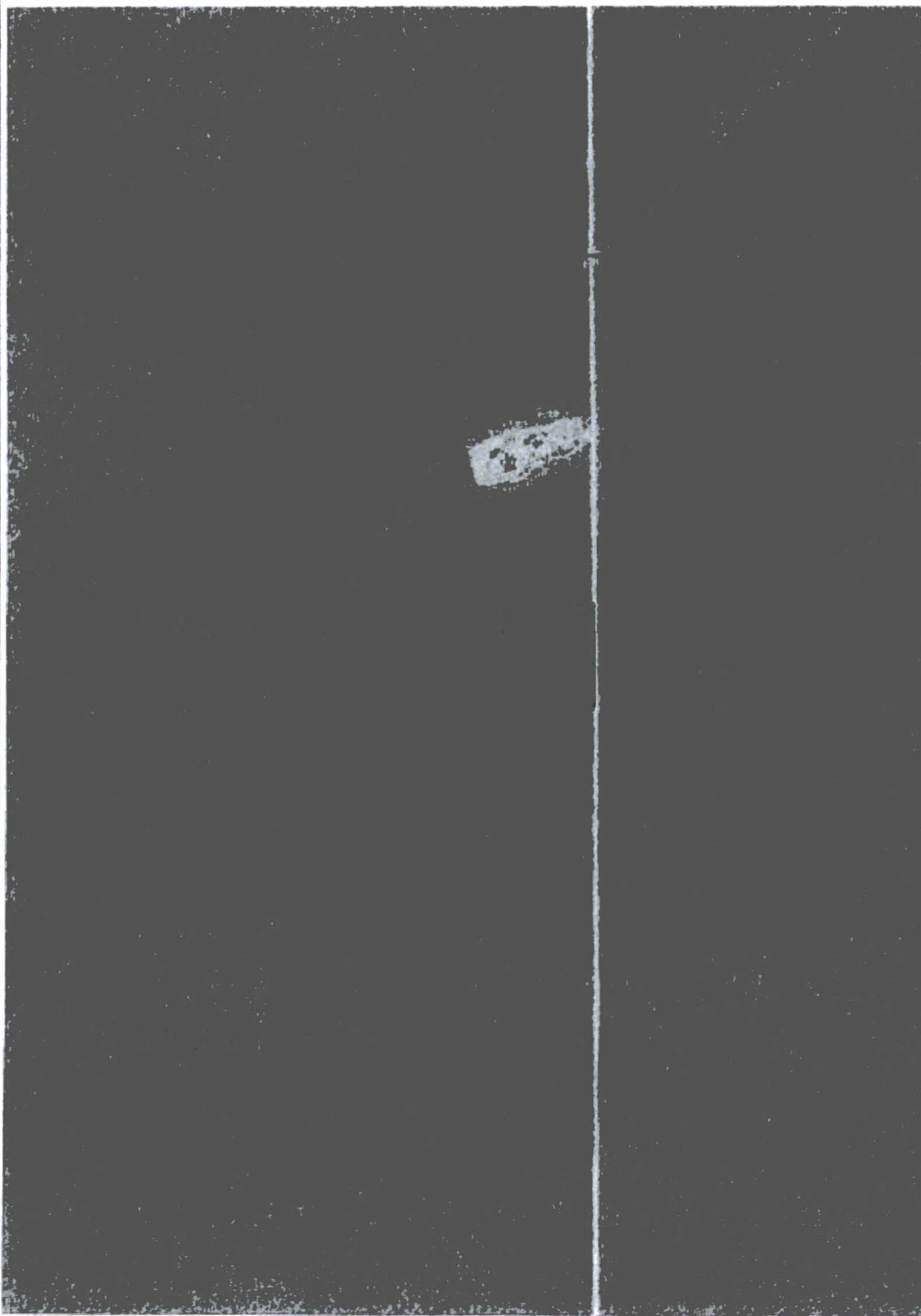

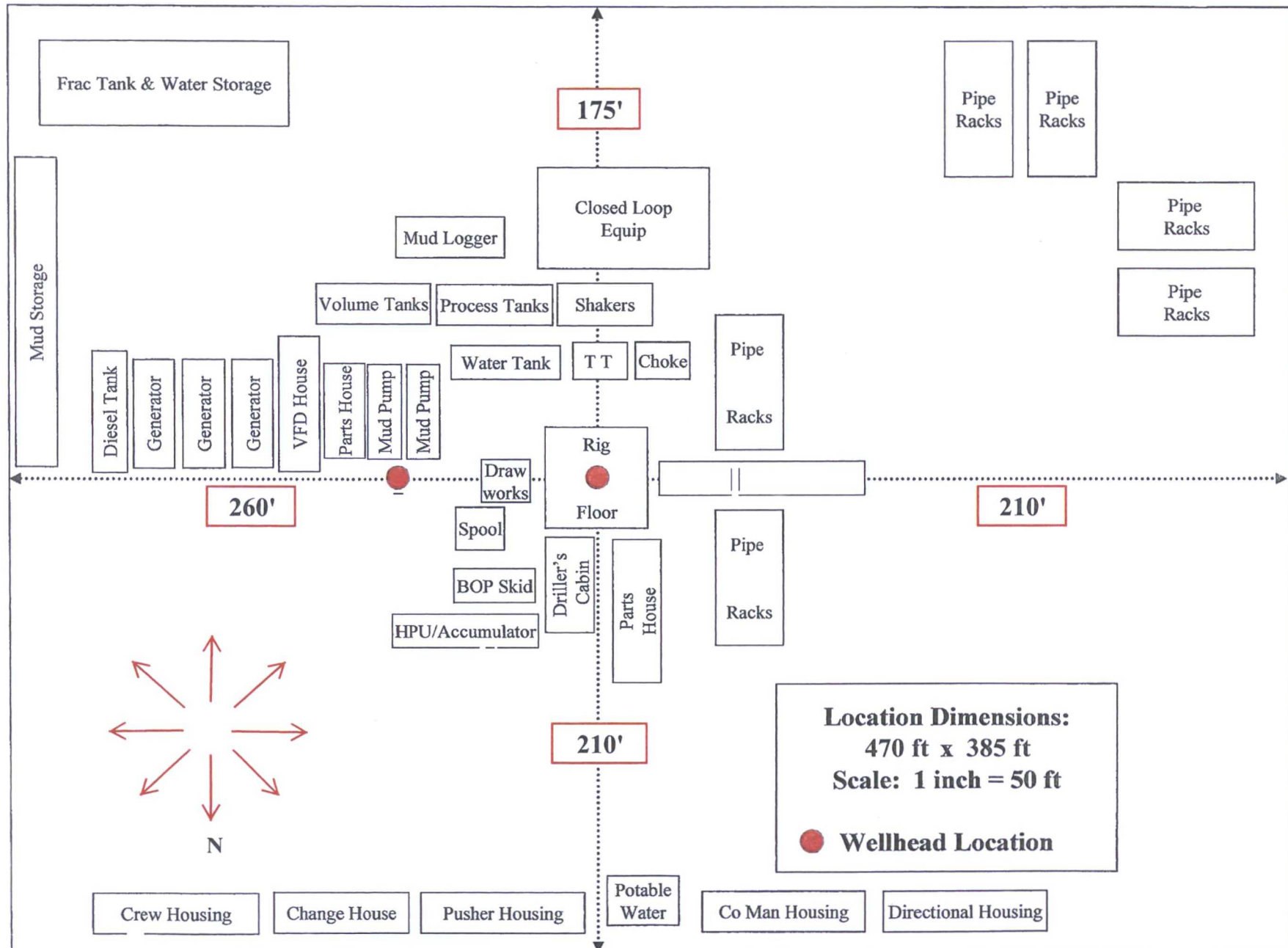

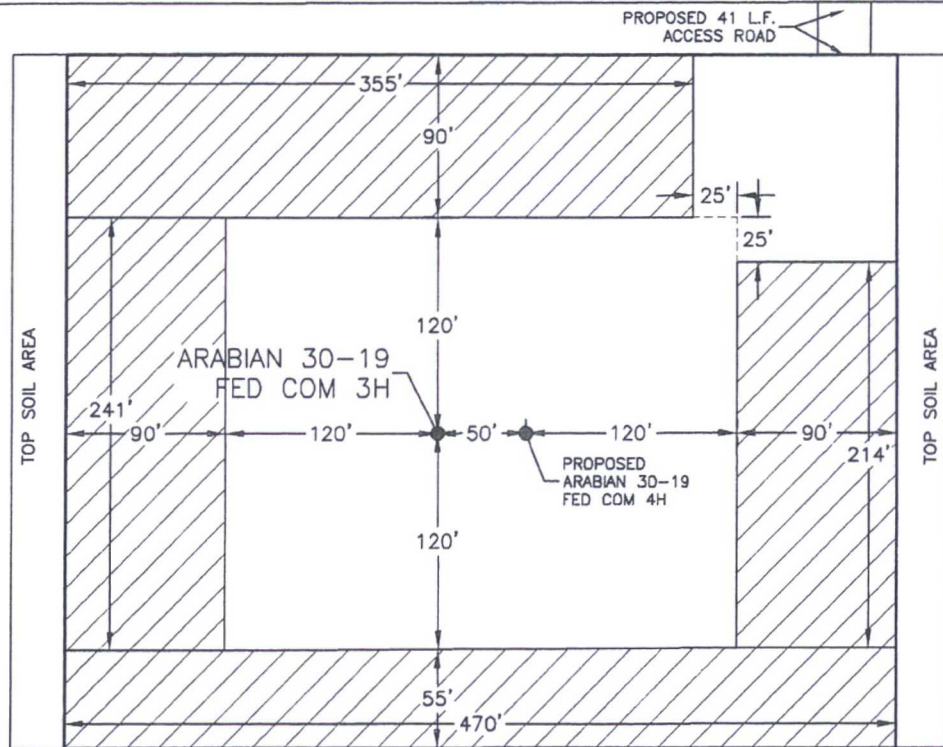
