Power pole down at cattleguard. OXY sign at cattleguard. NEED TO REMOVE CONDUIT, ROD PUMP, SIGN, AND POWER POLE. STUB OF POWER POLE SHOULD BE REMOVED OR CUT OFF 2' BELOW GROUND LEVEL. 1ST NOTICE.

Such enforcement may include this office applying to the Division for an order summoning you to a hearing before a Division Examiner in Santa Fe to show cause why you should not be ordered to permanently plug and abandon this well.

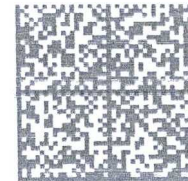
