Chevron USA Inc respectfully requests an amendment to sundry EC 474584 approved August 2, 2019. The total length of the 20' EDS ROW extension should be 1,993.14' in length. An updated certified surface use plat is attached to this request.

Justification: The proposed EDS ROW extends the existing EDS power line to the West in Section 15 of T26S-R32E in Lea County, NM over to the existing Pad 12 well pad. The current artificial lift method for wells SD WE 15 FED P12 1H-3H is gas lift. Due to frac hits, these wells have become loaded with water and the existing gas lift is unable to load these wells. A properly sized electric submersible pump will keep the water column moving up the well, allow further oil & gas
