This is to request approval of Final Abandonment. When this lease was plugged, Sonny Hope contacted Cheryl Post with the BLM in Roswell, NM requesting approval to leave the locations as is for use by the rancher (Lee Ann Williams Ranch, Rt. 2 Box 38, Lovington, NM 88260). Ms. Post advised Mr. Hope that she had inspected the locations in question, spoken to all concerned at the BLM and that this was approved and Vintage Drilling LLC was excused from all future reclamation of these locations. She further stated that she would send us a letter stating this. Mr. Hope contacted Ms. Post several times requesting receipt of the letter so that we could apply for final abandonment. She continuously stated it was approved and the letter would be forthcoming. We have since learned that Ms. Post is no longer with the Roswell office. We have since contacted several individuals with the Roswell office who stated that they would follow up on this. They have failed to do so and several of them are also no longer with the Roswell office.

Since we did receive verbal approval for our Final Abandonment and were excused from all future reclamation since the rancher has been and will be continuing to use these locations for his ranch operations, we respectfully request approval of Final Abandonment.

Attached are 2 letters sent to BLM in Roswell regarding this matter. All other contact was made by phone.
