4/8/68 Moved in casing pulling rig & set a cast iron bridge plug in the 5 1/2" 17# N-80 casing at 9000'. Dumped 20' cement on top of bridge plug.

4/10/68 Shot 5 1/2" casing at 8000'. Could not pull.

4/11/68 Shot 5 1/2" casing at 7500'. Started laying down casing.

4/16/68 Ran 2 3/8" tubing and placed a 25 sx cement plug at 7500'; a 25 sx cement plug at 5300'; and a 35 sx cement plug at 3910'.

4/17/68 Shot 8 5/8" casing at 1215' and started laying down casing.

4/18/68 Ran tubing and set a 25 sx cement plug at 1215' and a 25sx cement plug at 385'. Placed 10 sx cement in top of 12 3/4" surface casing and installed marker.
