

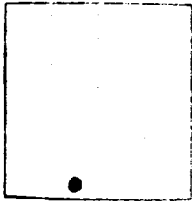

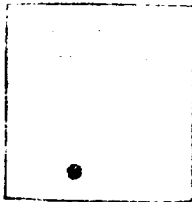

- Cut and pull all recoverable 4-1/2" OD casing
- Spot 20 on cement plug from 33' below top of non-recoverable 4-1/2" OD casing to 30' above top of 4-1/2" OD casing
- Spot 30 on cement plug 6605-6755'
- Spot 35 on cement plug 4104-4234'
- Spot 55 on cement plug 625-925
- Spot 75 on cement plug 437-537
- Spot 10 on cement plug and location marker at surface
