This well was completed on June 24, 1966. After acidizing perforations at 4242', 4248', 4254', 4261', 4270', 4276', and 4284' as shown on Well Completion Report filed June 27, produced well for short time prior to sand/oil frac treatment. On July 18 attempted to sand/oil frac but found indications of restriction so perforated with additional holes at 4282', 4277', 4272', 4268', 4258', and 4252'. Treated well using 1,000 gallons acid as spearhead followed by 29,000 gallons lease oil and 29,000# 20/40 sand. Maximum treating pressure 3500 psi. Maximum injection rate 30 BOPM. Immediate Shut In Pressure 2200 psi.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
