DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

This well was drilled to 3052' in anhydrite and shale. Ran 3045', 91.6 joints of 5 1/2" OD 14# 8in J-55 SS casing set at 3052' and cemented with 300 sacks of cement. Plug was down at 1:00 A.M. December 31, 1954. Cement was allowed to set 48 hours before testing for shut-off. Test was satisfactory. Drilling resumed.
