Date of proposed plugging - on or before June 1, 2001

- 1) Pull tubing & rods (if any)
- 2) Run in hole w/CIBP on tubing & set @ 2700' +/-
- 3) Spot 25 sacks of cement over CIBP & trip out w/tubing
- 4) Perforate @ 1400'
- 5) Trip in hole w/tubing & tag the bottom plug
- 6) Pull tubing to 1400' & pump 75 sacks of cement, leaving 100' inside the 5 1/2" casing
- 7) Trip out w/tubing
- 8) Perforate @ 180' +/-
- 9) Run in hole w/tubing & tag the middle plug
- 10) Pull tubing to 180' & pump 100 sacks of cement, leaving 100' in casing
- 11) Trip out w/tubing
- 12) Cap well w/10 sacks cement at surface & set marker

GENERAL INSTRUCTIONS
