Drilled 7-7/8" hole from 3830' to 9000'. Reached total depth of 9000' on 9-21-68 at 1:30 P.M. Circ. 3 hrs, COOH. Dresser-Atlas ran BHC-GR acoustic-caliper logs. On 9-22-68, set 287 jts of 4-1/2" casing (top to bottom as follows: 100', 11.6#, J-55 buttress, A-condition; 3500', 10.5#, J-55 buttress, A-condition; 3000', 10.5#, J-55 ST&C, A-condition; and 2400', 11.6#, J-55 ST&C, A-condition) at 8998', with Howco stage collar at 4824'. Halliburton cemented 1st stage w/500 sacks Trinity Inferno. Plug to 8961'. Rotated casing. Opened stage collar at 4824' w/500#. Circulated thru collar 6 hrs. Cemented 2nd stage thru collar w/280 sacks Trinity Inferno. Plug to 4824'. Closed stage collar w/1000#. Job completed 2:30 A.M., 9-23-68. Ran temperature survey bomb to 4790', TOC at 3600'. Released Cactus Drilling Company rig at 2:00 P.M., 9-23-68. WOC 18 hours, tested casing w/2000# for 30 minutes, held OK.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

Item 17: Proposals to abandon a well and subsequent reports of abandonment should include such special information as is required by local Federal and/or State offices.
