2. Plan to set and cement $4\frac{1}{2}$ " liner to shut off caving formation.
3. $5\frac{1}{2}$ " OD casing is set at 3042 feet. Will run approximately 60 feet of $4\frac{1}{2}$ " liner and set on top of pay at approximately 3053 feet and cement with 35 sacks. (The exact length and depth of liner to be set will be determined by Gamma Ray and Caliper logs.)
