

RECEIPT AND RELEASE

KNOW ALL MEN BY THESE PRESENTS:

That I, Leslie E. Estep + Mary C. Estep, owner in fee simple of the Northwest Quarter of Section 2, Township 14-5, Range 36E, Lea County, State of New Mexico, for and in consideration of the payment to me of the sum of Three Hundred & No/100 DOLLARS (300.00), by SINCLAIR OIL & GAS COMPANY, a Maine corporation, the receipt of which is hereby acknowledged, have released, discharged and acquitted, and by these presents do release, discharge and acquit said Company, its servants, agents and employees, of and from any and all liability to me for damage to my land, livestock, crops, domestic and stock water supply, and other property of a like or of a wholly different nature, occasioned by the operations of the said above-named Company on what is known as its C. E. Renshaw lease, described as the Northwest Quarter of Section 2, Township 14-5, Range 36E, Lea County, State of New Mexico, and agree that every claim, demand and cause of action that I now have or may hereafter have, against said Company by reason thereof, is in all things fully satisfied, released and discharged, this agreement to include any and all damages to land by reason of well locations, slush ponds, plants, stations, structures and other appurtenances employed in the operation of said lease.

And, for the same consideration, I agree, at my own expense and risk, to fill all slush ponds, remove all cement piers, foundations and anchor posts embedded in the soil and level all depressions, thus leaving the surface of the land in a condition satisfactory in all respects to me, and I accept the responsibility of said land in its present condition, it being the intent of this instrument to release and discharge said Sinclair Oil & Gas Company from any and all damages, accrued or to accrue, on account of said Company's operations or the abandonment of its operations on the above-described lease and on account of the present condition of said land.

The undersigned for the consideration herein expressed does hereby covenant and agree never to institute or prosecute either in law or in equity any cause of action against Sinclair Oil & Gas Company, its servants, agents and employees, for damages arising out of or connected with any of the matters and things hereinabove recited.

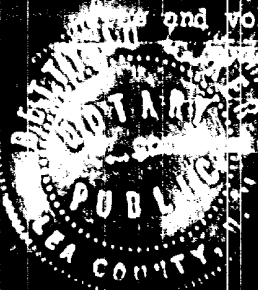
