TD 4760, set 9 5/8" OD casing @ 4758 and cemented with 2200 sacks of cement. Ran temperature survey which indicated top of cement behind 9 5/8" OD casing @ 990' from surface. Let cement set 48 hours and tested with 1000# pump pressure for 1 hour before and after drilling plug. No decrease in pressure, resumed drilling.
