DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Ran 11 joints 358' of 13-3/8" OD 8 RT B-2 48# H-40 SS casing. Set and cemented at 376' w/500 sacks Regular Lonestar Portland cement. Plug at 360'. Maximum pressure 150#. Circulated approximately 20 sacks cement.

After waiting over 24 hours tested 7" casing w/1000# pressure for 30 minutes. There was no drop in pressure. Drilled cement plug from 360' to 385', tested cement below casing shoe w/400# pressure for 30 minutes. There was no drop in pressure.

After approval of Mr. Yarbrough, State Oil and Gas Inspector, preparations were made to drill ahead.
